Therefore us materials with recycled content, such that the sum of post-consumer recycled content plus half of the pre-consumer content constitutes at least 10% (1 point) or 20% (2 points), based on cost, of the total value of the materials in the project.	Creative Mines Masonry Veneer Products contain a minimum of 70% pre-consumer recycled content. Pre-consumer material is defined as material diverted from the waste stream during the manufacturing process. Excluded is reutilization of materials such as rework, regrind, or scrap generated in a process and capable of being reclaimed within the same process that generated it.

<b>MR CREDIT 1.1-1.2: CONSTRUCTION, DEMOLITION AND RENOVATION – 50-75%</b>	<b>1 to 2</b>	Creative Mines Masonry Veneer Products may be completely recycled and may attribute to construction waste diverted during construction, as well as for future redevelop stages of that which may have existing stone in place. Stone would fall into the concrete category for Construction Waste Diversion.
<b>MANUFACTURED STONE</b>	<b>1 to TBD</b>	Creative Mines Masonry Veneer Products reduce the amount of natural stone excavated around the United States and the world. Plus, at half the weight, Creative Mines Stone considerably reduces installation time and costs, as well as shipping weights.
